

GUIDELINES FOR AUTHORS

Common agreement

In the "Volgograd scientific medical journal" in the form of articles accepted scientific work, reflecting the result of completed fundamental and practical research, relevant to the profile of the journal. The main headings of the scientific publication are: pharmacology, toxicology, morphology, experimental studies, pathophysiology, clinical medicine, new methods in the experiment and clinic, humanitarian problems of medicine. In addition to the original articles are accepted for publication lectures, thematic reviews, as well as the materials of the rubric "To help the practical doctor" describing case studies, new treatments, and more.

Design requirements

The article is provided in 2 copies with an electronic version. The electronic version is available on a diskette or CD with the extension .doc. The maximum size of the article is up to 10 pages for original articles, up to 12 pages for thematic reviews, including tables and all illustrative materials. The editorial Board reserves the right to shorten the article.

The article should be typed in Microsoft Word text editor, font - Times New Roman, 14 point, 1.5 line spacing, paragraph indentation 1.27 cm, formatting by width, without hyphenation and page numbering, borders: 2.5 cm on all sides.

The title part of the article should contain UDC, title of the article, surname and initials of the author(s), name of the organization and division in Russian and English.

Tables are placed in the text in the course of presentation. Illustrative material, with a total maximum area of up to 750 square cm and a TIFF extension, should be prepared for black and white printing. Accordingly, numbered figure captions are printed at the end of the article after the list of references. In the legends to microphotographs, it is imperative to specify the methods of staining and magnification.

Requirements for the order of presentation: brief update (without title), the purpose of the work, research methodology, research results (if necessary, with discussion), conclusion, literature, summary of the article (abstract) with keywords (Key words) in Russian and English.

The cited literature is given after the conclusion of the article in alphabetical order (Russian, then foreign sources). In the text of the article literary sources are given in the form of figures enclosed in square brackets, according to the list of references. The maximum size of the list used

literature should not exceed 15 sources. References to publications earlier than 1995 should be exceptions (priorities, basic methods, generally accepted standards and classifications). References to unpublished articles, abstracts and preprints are not allowed. Example links:

The work should be accompanied by:

- the letter of the title organization and the direction in the press of the head of division;
- completed (possibly by hand) and signed by two reviewers – direction (the form is available on the website);
- the article is accompanied by information about the authors in the amount of: surname, name, patronymic in full, academic degree and title, certified by handwritten signatures of all authors. For one of the authors the postal address for correspondence, contact numbers and E-mail are specified.

Preparation for publication and publishing rights

As materials become available, a portfolio of publications is formed. The final decision on the publication is made at the meeting of the editorial Board, taking into account the conclusion of the reviewer appointed by the editor-in-chief or his Deputy within 3 months from the date of receipt of the article. The date of receipt shall be the date of receipt of the final text by the editorial office. Rejected papers will not be reviewed or returned.

The authors' signatures under the article mean the authors' automatic consent to the publication in the main issue or Appendix on the terms of the editorial Board, the authors' guarantee of the rights to the originality of the information given in the article, compliance with international and Russian legal norms in experimental, preclinical and clinical studies, as well as consent to the transfer of rights to the publication and translations of this article to the publishing house of the Volga state University.

Publication in the " Volgograd scientific medical journal " is free of charge, the authors pay only the cost of the journal issue, sent to nonresident authors by mail, according to the submitted recipients. Form of payment-non-cash. The form for payment is provided on the website and on the last page of each issue of the journal. There is also information for those who wish to subscribe to the periodical.
