



MEMORANDUM OF UNDERSTANDING ON ACADEMIC EXCHANGE BETWEEN VOLGOGRAD STATE MEDICAL UNIVERSITY (RUSSIAN FEDERATION) AND YONSEI UNIVERSITY COLLEGE OF DENTISTRY (REPUBLIC OF KOREA)

Federal Government-Funded Educational Institution of Higher Professional Training under the Ministry of Health of the Russian Federation Volgograd State Medical University, the Russian Federation and the Yonsei University College of Dentistry, the Republic of Korea, hereinafter collectively referred to as the "Parties", with the objective of promoting cooperation in the fields of education and academic research, agreed to conclude the following memorandum of understanding on academic exchange.

Article 1

In the aim of increasing of educational and scientific potential Parties agree to develop collaboration in the following areas:

- (1) Activities such as collaborative research, lectures, symposiums, etc., and the exchange of researchers pertaining thereto;
- (2) Exchange of information and materials in those fields, which are of interest to both Parties;
- (3) Exchange of undergraduate and graduate students, masters;
- (4) Exchange of scientific publications and information;
- (5) Support of educational process by wide using of contemporary technologies and electronic resources;
- (6) Joint development of contemporary methods of prevention, diagnostics and treatment of dental diseases;

- (7) Medical equipment development;
- (8) Studying up-to-date and perspective samples of medical equipment.
- (9) Support and development of tele-health technologies.

Article 2

Specific matters pertaining to the implementation of the exchanges based on this memorandum of understanding shall be negotiated and agreed upon between the both Parties concerned in each specific case and may be stipulated in writing as appendix complementary to this agreement.

Article 3

Any disputes aroused at understanding, use and realization of current Memorandum will be solved friendly by the way of consultation between two Parties.

Article 4

This memorandum of understanding shall become effective on the date of its signing by the representatives of both Parties and shall be in force for five years and will be automatically prolonged for the next 5 year periods until one of parties ceases its action by the way of informing the other party in written form not later than 6 months before expiration of the current Memorandum of Understanding. Cancellation of current Memorandum will not influence on termination of already started projects and program in scope of current Memorandum if Parties did not agree in another way.

Signed in Volgograd, the Russian Federation on $\frac{1}{\sqrt{100}}$ December 2018 in two copies in English and both copies have equal force.

Article 5

This memorandum of understanding is not intended to, and shall not, create any legally binding obligations and does not constitute, and shall not be construed as, a proposal, commitment, or an offer on behalf of any Party and/or any of their affiliates to proceed with, or enter into, the transaction(s) contemplated by this memorandum of understanding.
