# Rules for writing a practice diary

A mandatory reporting document on a student's internship is a practice diary. The practice diary should include protocols of various types of work (literary/methodological/experimental/analytical/other types of work) performed by the student during the internship.

Protocols are drawn up for each day of work in practice. The protocol must contain information about the date, topic(s) of the lesson(s), and work performed during the individual assignment.

When logging work on completing individual tasks (IT), you must adhere to the following algorithm:

- 1. Describe the essence of the task (goals/objectives/algorithm/method of execution, etc.)
- 2. Record factual data it is advisable to present it in a tabular format.
- 3. It is necessary to display personal participation in carrying out activities to perform the functional duties of the ward nurse, recording everything that was done, observed, and participated in (i.e., the types of work that are performed during working hours are indicated).
- 4. Records must reflect the entire scope of work performed, be concise and clear.
- 5. It is necessary to make a brief conclusion based on the results of the IT.

## The practice diary must be signed:

- a) after each protocol by the nurse under whose guidance he performed the work.
- b) on the title page by the head of practice from the organization (university) and the head of practice from the specialized organization (base of practice)

# **Introductory information for students**

The objectives of the practice are:

- study of the functional responsibilities and working conditions of a ward nurse in therapeutic departments;
- acquiring skills in communicating with therapeutic patients, their legal representatives, medical personnel, implementing the principles of medical deontology;
- training in differentiated care techniques for the most common pathologies and provision of pre-medical care in emergency conditions;
- acquisition and consolidation of skills to promote a healthy lifestyle;
- acquisition of skills in preparing basic types of medical documentation for a nursing station.

During practice, the student must gain skills (activity experience):

- carrying out manipulations to ensure the maintenance of personal hygiene of seriously ill patients (assistance with the morning toilet, creating a comfortable position for the patient);
- carrying out manipulations to ensure the maintenance of personal hygiene of seriously ill patients (toilet of the skin, mouth, ears);
- carrying out manipulations to ensure the maintenance of personal hygiene of seriously ill patients (washing hair);
- carrying out manipulations to ensure the maintenance of personal hygiene of seriously ill patients (giving a bedpan, urinal);
- carrying out manipulations to ensure the maintenance of personal hygiene of seriously ill patients (toilet of the external genitalia);
- carrying out manipulations to ensure the maintenance of personal hygiene of seriously ill patients (skin care, prevention of bedsores);
- measuring the patient's body temperature (graphic recording in the temperature sheet);
- feeding the seriously ill;
- counting respiratory movements;
- blood pressure measurement;
- determination and counting of the pulse on the radial artery;
- preparing the patient for ultrasound of the abdominal organs, retroperitoneum, bladder;
- preparing the patient for esophago-gastro-duodenoscopy, radiography of the stomach;
- preparing the patient for colonoscopy, irrigography;
- conducting a cleansing enema;
- changing underwear and bed linen for a patient with limited mobility;
- provision of first aid for heart pain;
- provision of first aid in case of hypertensive crisis;
- provision of first aid for fainting and collapse;
- provision of first aid for hemoptysis and pulmonary hemorrhage;
- provision of first aid in case of sudden shortness of breath (choking);
- provision of first aid for vomiting;
- provision of first aid for external bleeding;
- provision of first aid for renal colic;
- carrying out resuscitation measures (artificial ventilation);
- carrying out resuscitation measures (closed cardiac massage).

# Upon completion of the internship, the student should know:

- organization of therapeutic care in the Russian Federation;
- structure and organization of work of a therapeutic hospital;
- sanitary and hygienic requirements for the structural premises of departments
  - therapeutic profile;
- medical and protective regime of health care facilities;

- functional responsibilities of a ward nurse in therapeutic departments;
- basic principles of medical ethics and deontology;
- concept of general and special care;
- features of care for patients with various therapeutic pathologies;
- cardiopulmonary measures;
- algorithms for providing first aid for various conditions.

### The student must be able to:

- comply with labor protection, safety, sanitary and hygienic rules norms;
- measure height, weight, body temperature, blood pressure, pulse rate, respiratory rate

movements;

- prepare the patient for laboratory and instrumental studies;
- transport the patient;
- provide general and special care for patients with various pathologies;
- provide first aid;
- carry out resuscitation measures.
